TCVESSA Specialty - Obedience/Rally Update

Both regular and non-regular Obedience and regular Rally classes will be offered at the TCVESSA Specialty show on Thursday August 21 and Friday August 22 at the Anoka County Fairgrounds. A couple of new things to take note of this year are that the obedience classes will be starting at 7 a.m. with Rally to follow. And, for the first time, we'll be offering the Graduate Open obedience class.

Judging both obedience and rally on Thursday will be Ms. Cynthia Rustad from Plymouth, MN. On Friday, both obedience and rally classes will be judged by Mr. Dan Herald from Duluth, MN. These two judges received the most votes by club members on the "Judges Survey" that was sent to club members interested in obedience last year, so we were very lucky to get our two top picks.

The 7 a.m. earlier start time was selected so that the obedience and rally classes would be completed before the conformation sweepstakes classes would begin. We are trying to minimize conflicts so that club members can enter

or watch as many of the classes as possible. We also wanted to offer all the regular and non-regular classes in order to give all exhibitors, regardless of level, the opportunity to participate.

Also, we are looking for a chief ring steward for Obedience and ring stewards for various times. If you can help out, we'd be glad to try to work around your schedule. Please email Jean Dockendorf.

class helps fill the gap between Open and Utility, just as Graduate Novice does between Novice and Open. It was adopted by the AKC in 2005, and is starting to be offered at more and more shows in this area. In January 2009, Graduate Open will become a titling class, and dogs who earn three qualifying scores will be awarded the GO title. The basic differences between Graduate Open and Utility are:

- 1. The signal exercise is done at a closer distance;
- 2. Scent discrimination is done with only one article retrieved from a group of four;

- 3. There is no center glove in the directed retrieve
- 4. The go back is done from the center of the ring;
- 5. The handler can pause on the moving stand;
- 6. Directed jumping is done as a separate exercise from the go back and the dog is only given one jump to perform.

Graduate Open is ideal for handlers who are looking for a "kinder & gentler" Utility class, and it's an ideal way to prepare to earn your "GO" title next year.
