## **June 26 Board Minutes**

Attendees: Julie Roberts, Cyndi Myhre, Kris Radermacher, Francie Nelson, Carmen Laing, B.A. Breese, and Kathy Raidt

**Previous Meeting Notes**: March 16<sup>th</sup> board meeting notes - A motion was made by Cyndi Myhre to accept the notes as corrected. B.A. Breese seconded the motion.

**New Business**: There were no new membership applications to consider this month.

**By-Laws**: Kris Radermacher reported that the AKC returned our by-laws with only a few changes. A membership vote must be taken to approve the final by-laws with AKC revisions included. Cyndi Myhre proposed that the sweepstakes formula (for cash wins) be adjusted to be consistent with prior years.

Ribbons were discussed, and the board indicated its preferences.

Social Hour: A number of catering options were considered without a final decision.

**Calendar**: Kris Radermacher proposed a general membership meeting before the national specialty. We'll plan a November general membership meeting on November  $22^{nd}$  or  $23^{rd}$  at C & E. Carmen will see if they are open either day. The board proposed beginning at noon. Carmen will be the coordinator for this general meeting and associated fun match.

**Newsletter**: Kandice Bierle has accepted the job of newsletter editor and she is requesting information from the board. It was suggested that she contact Heather Rand, our legislative liaison, for updates. Classified ads can be offered when space is available.

**Standing Rules**: There was considerable discussion concerning the need for standing rules, and what they should be. It was decided that Julie would send out the long version of the draft document for discussion at the next board meeting.

**Next Meetings**: The board will meet July 24<sup>th</sup> at the Minnetonka Byerly's. The August meeting will be August 11<sup>th</sup> to be devoted to the specialty. Our September meeting will be September 18<sup>th</sup>.

# **Proofing Your Obedience or Rally Exercises in New Locations**

Success in the show ring at an obedience or rally trial can never be guaranteed, but one sure way to improve your performance is to proof your dog in a variety of locations. No matter what level you're training for, your dog can benefit from learning to confidently perform each exercise in as many new locations as possible.

Having a training facility that you work with regularly is extremely beneficial when teaching new exercises and maintaining a regular training schedule. But after your dog has mastered the basics of each exercise, traveling to different training centers will allow you to see how well your dog really understands the commands. In addition, a new location will also allow you to measure whether your dog is performing each exercise correctly on the first command. And, you can also make sure your dog learns that going to new locations can be fun!

There are a number of ways to visit different facilities, some of which include run-thrus, drop-in classes, renting ring time, seminars or fun matches. All are great ways to get your dog working confidently in new locations. (See the following page for a few facilities that offer these opportunities).

When looking for facilities to proof your dog, make sure to find a variety of facilities:

- some that have pillars in the ring and some with no obstructions
- some with flat walls and some with baby gates
- some with low ceilings and some with high ones that make hearing difficult or create echoes
- some that have dim lighting or darker areas and some that are brighter

Traveling to new facilities also allows your dog to get used to other voices calling commands. It's always a good idea to have new faces and new footsteps following behind your dog after each exercise. Going to new training centers is also a great chance to work with the distraction of other breeds of dogs than you may typically work with at home.

Training at a new facility allows you to help your dog through any difficult problem areas by taking off the pressure to score well at a show. When you first visit a new facility, start with simple commands to build confidence and then work up to the level you are proofing for show. If necessary, break complex exercises down into smaller segments or do exercises from closer distances to encourage success. Remember to keep it fun for the dog.

Keep going to the same place two or three times until your dog is confidently performing all exercises and is no longer distracted. Then try a new facility to test your dog's performance.

While visiting new facilities doesn't guarantee a perfect run, if you can perform all exercises correctly on the first try in three new locations, the odds are definitely in your favor!


