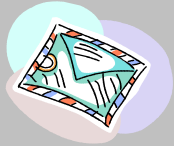

According to our by-laws, a dues notice must be sent by the club secretary to all members in October, and dues payment (or, for Life Members, return of the membership information form) must be received by December 31.

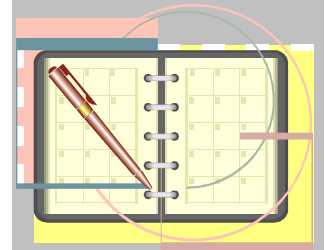

## AGILITY COMPETITION NEWS

### Agility Invitational 2010 by Patty Salzwedel

We are back from the Agility Invitational, so for those of you that have not heard, I am sending out a quick recap. First off, we had a blast! The weather in California was warm, great to see old friends and the running conditions were super. It was so great to be inside on sod. The AKC agility team even treated us to coffee, tea and hot cocoa for our Saturday

morning walk-thru. A nice thing when you started at 6 AM! It was an honor to be there once again with a mother/daughter team and represent the Springers.

This year's courses in general were very tight and technical. Many good teams faulted and feel victim to courses that were more "international" in style. Teamwork and precision was a must if you were to get through the 4 rounds. The days also were long and exhausting.

My Brooke ran awesome for 4 clean runs to make into the 20” finals. Out of 98 dogs, Brooke was ranked 7<sup>th</sup> going into the finals. She hung in there for a 10-year-old girl and was still barking like a nut on the start line at the finals Sunday afternoon. Brooke ran beautifully on a very technical start. I caused the dropped bar; I kept her on my hand too long on a speed line out of a tunnel. I also think she could not hear my command with the loud roar of the crowd. We were both a bit overwhelmed with how loud it was on the course. By the time she looked away from me, Brooke was on top of the bar. I am so proud of her and her enthusiasm. Brooke also won the honors of Top English Springer Spaniel at the Invitational.

Kelly ran 3 perfect rounds. It was just one bobble on my part in round 4 that caused her to miss the weave pole entry to keep her out of the finals. Up to that point she was ranked #7 in a large and competitive 16” class.

Of the two girls I am glad that Brooke could be the one to make it to final; it was her year to shine and she deserved it. I love that girl with all my heart—she would do anything for me. At the age of 10, I never dreamed we would still be competitive at a national level. To date, Brooke needs 3 more double Q’s to finish her MACH 6 and then she will officially retire from agility. I want her to retire happy and healthy. She is by no means ready to sleep on the couch, so she will play in obedience and maybe try for a tracking title.

I was also very proud of another MN Springer team, Jan Baker and her girl “Chaos.” Chaos is a wonderful female with a lot of heart and was bred by Pat Welch. Jan and Chaos also ran 4 clean rounds and were ranked #10 overall. In the 20” height division, 10 dogs are chosen for the finals round. So Jan and Chaos really earned a spot in the final, BUT the rule is, they only take one dog from each breed in each jump height. Because Brooke also qualified, Chaos had to bump and they took the #11 dog instead. Jan and Chaos exhibited great sportsmanship and cheered loudly for us in the stands. I am confident this great team will be at the invitational again next year.

In other venues, I know Melissa competed in Junior Showmanship with her Springer and Jon Pidde competed in Obedience with his Springer Benson. I never was able to sneak away to watch, but heard they had fun as well.

## Food Allergies: Don't Blame the Grains by Heidi Buytaert, DVM

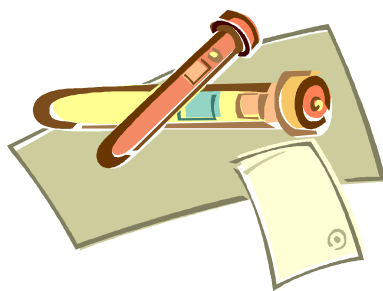
Allergies in dogs cause skin problems which usually manifests into very itchy skin that can become red, cause a rash, or even bald patches. This will usually lead to a secondary skin infection. Allergies mean an uncomfortable dog and many trips to the vet.

Many people erroneously assume itching due to food allergy requires a recent diet change. In fact the opposite is true as most food allergies take time to develop. Many animals have been eating the offending food for years with no trouble. In fact, the majority of food allergies occur between 2 and 6 years of age. Your veterinarian will want to rule out things including mites, flea bit allergies and contact allergies. If these are negative and your dog is affected year round by allergies then you must also rule out food allergies.

Inhalant allergies are the most common allergies seen in dogs. However, food allergies do account for 10% of the allergies seen in dogs and another 10% have a combination of food and inhalant allergies. It should be noted that food intolerance is also common, but the distinction is that food intolerance will result in diarrhea and/or vomiting.

Contrary to popular belief, only 3% of food allergies in dogs are caused by the grain. The majority (or 97%) are caused by a protein source. In order of most common offenders in dogs are beef, dairy, chicken, lamb, fish and soy.

There is not an accurate blood test to find food allergies. This may be confusing because there are commercially available food allergy blood tests, but I repeat – they are **not** accurate. The only way to diagnosis a food allergy is by doing a strict food trial. This consists of feeding a novel protein diet or using a hypoallergenic prescription diet. The



novel protein source consists of a protein source that the animal has never eaten before. There are several examples nowadays including rabbit, venison, herring etc. I recommend that clients stay away from beef, chicken, turkey and even lamb when performing a food trial. Your veterinarian should be able to work with you to find an appropriate novel protein diet. In contrast a hypoallergenic diet is a specialized diet that has been hydrolyzed or broken down so that there is a smaller pro-

tein molecule that is not large enough to trigger an allergic reaction. Either approach is fine for a food trial and the novel protein diets tend to be a little less costly. However, if the novel protein diet does not work, you would still need to do a food trial using the hypoallergenic diet.

The important part of a food trial is that the dog only gets that food during the 12 weeks of the food trial. You will likely not see results after 2-4 weeks, especially in highly-affected dogs. This means no treats, rawhides, pigs ears, flavored medications or even Heartguard chews, which contain beef. Some owners will choose to use the canned version of the recommended food and freeze meatballs of it to use as treats. Probably one of the biggest problems with food trials is table scraps, so I recommend keeping the dog out of the room when eating as even a small lick can ruin weeks of a well-followed food trial.







### (Food Allergies, continued)

The treatment for food allergies is avoidance. If a food trial is successful, you can go on feeding the food trial for life or proteins can be added back to the dog's diet one protein type at a time. However, it should be noted that allergies to new foods can develop in the future.

I know that food trials can be a pain in the butt. However, I am always very glad when a dog is positive for food allergies. This means fewer visits to the vet and less medications to control the allergies. The really cool thing is the only difference is the food and you were feeding them daily anyway!
