I get asked this question a lot by many different spaniel folks. So, I will attempt to answer this question as it pertains to the English Springer Spaniel. The Working Dog (WD) and Working Dog Excellent (WDX) are titles that are earned from the English Springer Spaniel Field Trial Association (ESSFTA), not the AKC. The intent of these tests is to discover if your Springer has the basic hunting instincts and traits necessary to assist the upland game hunter in the field during the pursuit of game such as pheasants, chuckars, and quail. Each Spaniel breed parent club oversees the requirements needed to pass a working dog test so each test may be slightly different depending on which breed is in the field. For this article, I will focus on the Springer but may reference the Boykin to give you an idea of the differences.

First, I should clarify that the WD and WDX are not true AKC titles, but certifications you earn from the parent club; however, you may place the WD and WDX at the end of the dog's name once they have passed the requirements of the working dog test.

For the Springers, the test is broken down into eight (8) categories that the judge will be looking at compared to the Boykin test that is just seven (7) categories. However, most of the requirements are the same regardless of the breed.

In basic theory, the working dog test is very much like a junior or senior hunt test. Many of the parent clubs state that if your dog passes a junior or senior test at a parent club sponsored hunt test, they will also earn the WD or WDX. That is yet another reason to participate in the hunting test at the National

Specialty and why I am always asking about the hunt test during the national. This year it may not happen because like everything else there is a bird shortage. Many hunt test and field trial clubs are having a hard time locating enough birds to hold tests and field trials. During a typical field trial weekend, 2.5 birds per dog are needed. If you have 50 dogs per day and it is a 2-day test, which is typical of most AKC Spaniel tests, that adds up to 250 birds needed for the weekend.

Anyhow back to the working dog test.

#### The 8 areas a judge looks at are:

- Dog under handlers' control
- •Covers ground in a workmanlike manner
- Finds and flushes birds
- Marks and retrieves birds
- Steady on line- water
- •Retrieves bird from water
- Does not display gun shyness.

Each category is rated as Excellent, Satisfactory, or Poor. To earn the WD the dog must receive a satisfactory rating in every category. To earn the WDX the dog must earn an Excellent in every category. A test must have at least three Spaniels of any breed to be considered a valid test.


What follows is a brief synopsis of each category requirement. A full set of rules may be found on the ESSFTA website.

#### Dog under handlers' control:

Does the dog listen to verbal and whistle command without disrupting the hunt.

#### Covers ground in a workmanlike manner:

Does the dog quarter, covering the ground using their nose and with desire to hunt all cover.



#### Finds and flushes:

Does the dog use their nose to locate and put-up game without undue urging.

#### Marks and retrieves birds:

Does the dog mark and retrieve the downed game? For a satisfactory score, the dog need only return it to the proximity of the handler. Most judges will tell you within a step of you. For an excellent rating, the dog must deliver to hand.

(Continued)

#### Steady on line – water:

The retrieving line on a water test is near the bank indicated by the judge. In the WD test the dog may be lightly restrained. For the excellent, the dog must sit at heel until released by the handler.

#### Retrieves bird from water:

Does the dog enter and swim out and retrieve the bird without undo urging. As in the land retrieve the bird would just need to be to the proximity of the handler for the WD and to hand for the WDX. The water retrieve will be a minimum of 15 yds, but junior hunter tests are around 30 yds.



#### Dog does not display gun shyness:

The dog should have enough desire as to show little reaction to the gun. For the WDX the dog should have enough desire to show no reaction to the gun.

**Authors side note.** When Ozzy hears the gun, he thinks that means go and is headed out on the retrieve. Hopefully, I'll have it fixed soon, but every so often he forgets that I need to give the command first. He has such an intense desire to retrieve that he knows what happens when he hears a gun. A bird will fall from the sky.

One last note: A dog with a hard mouth will fail any test. After all, we hunt to put food on the table so if the dog brings back a bird that is all chewed up or crushed and not fit for the table it defeats the purpose of having a hunting dog.

If you would like to try and have your dog earn his or her WD or WDX, the Minnesota Hunting Spaniel Associations will be having a training day and working dog test open to many spaniel breeds in June. Once a date has been chosen, I will let club members know when it is. I know it is going to be at Good Go-Ing Kennels over in Baldwin WI. The events are run with training in the morning and the working dog tests in the afternoon. We usually have a potluck or lunch between training and the test to give the judges time to get the test set up and for people to get signed up for the test. You may sign up for morning and or afternoon sessions, which is helpful in case you are not sure your dog is ready for the actual test.

If you have any questions about the test, there are several club members that have run the test in the past that can help. I am a member of MHSA and I'm happy to answer any questions about the grounds and AKC tests as well.

My last parting thought as with anything is just go have fun with your dog and let them do the job, they were bred to do.

Meeting was called to order at 7:04 p.m. by Courtney Hansen. Minutes from November 18, 2020 were approved. Treasurer reported \$9503.19 Secretary reported new member application by Laura Schriner.

#### **Old Business:**

Meeting was called to order at 7:05 p.m. by Liz Pike.

Minutes from January 17 were amended to remove the duplicate of Julie and add Diane as present. Moved by Kathy Patregnani, seconded by Diane Slais to approve as amended; motion carried.

BA reported that there is \$12,620.81 in the treasury after a very successful January agility trial.

Secretary report from Alice: all current (2020) members have renewed. We had the first reading of the new member application by Laura Schreiner from Green Bay (interested in agility, will be getting a puppy from Kathy).

#### Old Business:

January Agility Trial Debrief – Filled and made money! Club members who worked the weekend have a received a free entry in appreciating for their heroic efforts. We discussed the "best practices" during COVID – using text and FB to signal when it was time to run so people felt really safe. Kathy suggested we contact Michelle to understand what rules she will have in place for the May Specialty. Tekla and Courtney will be Des Moines this weekend and will be able to tell us how they handle different aspects of the show.

The 2021 Specialty and All-Breed Obedience/Rally Trials -Final approvals have come through from AKC. Jean suggested we encourage people to groom outside. Jean suggested we use the same technology set-up for people to see on FB live the pace/place of classes during the show. A question was raised about security in the parking lot as people will be going in and out frequently. Liz will check with Michelle on security and Brian offered to help patrol when not showing. The February 17th minutes were approved. The second reading for new member, Laura Schreiner took place. A motion was made, seconded and moved to accept her as a new member. Mary Dahl will send out a welcome packet to her.

Treasury report was for the sum of \$11,801.95. One upcoming expense is for a large Ruffland Kennel to be raffled. Brian Schaffer is taking care of this.
