## Fast-CAT

We were super excited when Joan Beck contacted us asking us to write an article on Fast-CAT as it is something that our Archie and Auggie really enjoy as do Kevin and myself.

CAT stands for Coursing Ability Test. The AKC Fast CAT event is a timed 100 yard dash

where an individual dog chases a lure in an enclosed fenced track. The lure is, actually, a plastic bag but to the dog it is a "bunny"! A football field is 100 yards long so, that gives you some idea of the distance your dog runs.

### What dogs are eligible?

Your dog must be at least 12 months old to participate and have an AKC number. An AKC Canine Partners number is for mixed-breed dogs and dogs ineligible for AKC registration. Spayed and neutered dogs can compete. Females in season are not eligible to compete at that time. Prior to your dog's run, it must head to the inspection committee table where it will be checked to make sure it is not lame and is fit to run.

### What should you bring to the Fast CAT event?

There are a couple things you will want to have with you at an AKC Fast CAT event. First, you will probably want kennels if you are bringing more than one dog. While running one dog, any other dogs you have need to be safe. We kennel the dog that is not currently running and have a lock on that kennel

since the running track can be a distance from our car and we want our dogs safe. Try to arrive at the event early so you can get a shady spot, if at all possible. You will want items to keep your dog cool after the run. We run battery operated fans and have our dogs on cooling mats. These mats are the size of our kennels and become activated with the dog's body weight. They work! They are, also, super easy to clean especially if the track is wet (the event is held rain or shine) and the dog has gotten dirty. We, also, have spray bottles with water in them and, if it is really hot out, we spray them prior to putting them on their cooling mats inside the kennels. Many Fast CAT events have a kiddie pool for dogs to lay down in and splash around in to cool off. I could spend all day just watching the dogs that do that! Ours prefer not to!



### Will you need any help to participate?

It is easier if you have a friend come with you to the AKC Fast CAT event. One of you would release the dog at the starting line and the other would catch the dog at the finish line and cheer the dog on as it runs the track. If you go to the event alone, a committee member will release your dog for you. If that's the case, you will need two leashes (one for the releaser and one for yourself at the finish line). Dogs can run with collars on but all tags must be either removed or taped up to the collar to prevent

anything from getting caught in the lure line.

### How do you get a Fast CAT title?

The miles per hour that your dog runs is considered points. There is a handicap for smaller sized dogs. For example, dogs below 20 inches at the withers have a handicap of 2. A dog having a handicap of 2 will have to multiply their mph by 2 to get the correct number of points of earned.

**Fast CAT Titles earned are: BCAT (150 points), DCAT (500 points), FCAT (1,000 points).**

And, then, you get a number attached to an FCAT title for each additional 500 points so, FCAT1 means your dog has earned 1500 points. You can see how your dog is doing compared to other dogs in the same breed by going to the [akc.org](http://akc.org) site and search for Fast CAT Top 20 Dogs. You can choose what year rankings you want and what breed you want to look at. Maybe your dog will be the fastest in its breed and make it into the AKC Fast CAT Invitational!

### What have Kevin and my experiences been at Fast CAT events?

We went to our first Fast CAT event in July, 2021 so we are still newbies. We have had a very positive experience at every event we've gone to. The committees are well organized and everyone is super friendly and helpful. The events range anywhere from 3 days to 6 days. Some of the events, also, have CAT. CAT is different than Fast CAT. The CAT event takes place in a huge, fenced-in area. Here dogs chase a lure on either a 300 or 600 yard long course. This is not a straight course as it has turns in it. Smaller dogs or senior dogs can run the 300 yard course while others run the 600 yard course. The dog chases a lure, just like in Fast CAT but, of course, for a much longer stretch! The dog must finish the course in 1 ½ minutes, if running the 300 yard course and in 2 minutes if running the 600 yard course. For this event you only earn either a pass or a fail. You earn titles based on how many passes you get.

**CAT Titles you can earn include: CA (3 passes), CAA (10 passes), CAX (25 passes), CAX#.**

Think about it, your dog can earn its CA title in one weekend!

We run our two English Springer Spaniels, Archie and Auggie. Archie LOVES chasing the lure. You can tell the dogs who love chasing the lure, while standing in line waiting their turn to be on the running track. They never take their eyes off the lure, they are pulling on their leash, they might be barking with excitement. That's our Archie!!! Auggie however, does not care about the lure at all and shows no excitement in the waiting line! He just loves running and loves running the 100 yards to Mom! If the Huntmaster isn't moving the lure very fast, Auggie doesn't run fast. So, Kevin tells them, at the starting line, to please keep the lure way ahead of Auggie and moving at a good clip so that Auggie can run his best. They accommodate that request and Kevin is not the only one who makes that request. No need to do that for Archie! He is laser focused on that lure. When he crosses the finish line, he will grab the lure (plastic bag) and shake it.



You can train some dogs to have an interest in a lure. You can tie a plastic bag to the handle part of a broom and try to entice your dog to think of it as

a toy or game to catch the bag. We, however, had no such luck with Auggie! He just thinks it's stupid!

If there is a CAT event, in conjunction with the Fast CAT event, Archie is there! We can't run Auggie in CAT since he has no interest in a lure. We were super worried the very first time we put Archie into a CAT field. Would he be fit enough to run that distance (600 yards) at a fast speed? Would he stay focused on the lure for that long? No need to worry!!! He LOVED it!

### Summary:

If you haven't tried Fast CAT (or CAT) yet, go for it! Whether you have an Archie-type dog, who loves chasing the lure, or an Auggie-type dog, who just loves running to its owner and could care less about the lure, your dog is getting exercise and having fun. You get some exercise too as you walk back and forth that 100 yards! Some events have a golf cart to transport people from the starting line to the finish line so, if you have problems walking, you could check into that before registering for the event.

Oh, one more fun fact about FastCAT! The Huntmaster will yell "Tally Ho" when the lure is released and your dog takes off down the track! We always get a kick out of that!

### Quick Tips For Keeping Your Dog's Joints Healthy.

(A synopsis from the July/August 2022 issue of the AKC Family Dog Magazine)

We all want our dogs to stay as healthy as possible and healthy joints are an important part of that equation. When it comes to joint health there are four main areas of importance. Genetics, nutrition, exercise and sterilization.

**Genetics:** Most of us know that genetics are key to good joints. The American Orthopedic Foundation for Animals (OFA) tells us that breeding animals with better joints tends to produce animals with better joints; however, there are too many genes involved with each joint combination to have specific genetic tests for joint health. Choosing animals with good genetic histories improves the odds that your dog won't have bone and joint issues.

**Nutrition:** Nutrition is a key factor for healthy joints. In a nutshell, keep your puppy/dog lean throughout its life. Studies have shown that heavier dogs have a higher incidence of joint issues.

**Exercise:** Exercise is critical to proper growth, but overuse of growing bones, tendons and ligaments can cause long term damage. It appears best to allow puppies to exercise naturally until they have stopped growing. Forced exercise, including treadmill work, long distance trotting or running and agility jumping should be avoided until after growth has stopped.

**Sterilization:** How does sterilization affect joint health? Much of properly regulated bone growth is governed by sex hormones that are lost with spay and neuter. We now know that early sterilization in dogs delays the growth plate closure in the bones causing them to grow past their desired length. These larger and longer bones put strain on the ligaments and tendons that attach to the bones. The extra stress on attached structures appears to account for both increasing number of ruptured ligaments and tendons as well as stress on the joint itself leading to possible hip and elbow dysplasia.

## **TCVESSA BOARD MEETING MINUTES – 2-3-22**

Board Members Present: Liz Pike, B.A. Breese, Alice Musburger, Courtney Hansen, Kathy Patregnani, Julie Roberts, Carmen Laing, Tekla Viker, Diane Slais. TCVESSA member Joan Beck, Mary Dahl and Mary Haggerty also joined the ZOOM call.

A motion was made to approve the November '21 minutes by Liz. B.A. seconded.

Alice, in tandem with Julie, provided the Secretary's Report. First readings were done for Rita Bakalar, Maria Barton and Demelza Homes. The second readings for Sterling Erickson; Jill, Cody and Grady Dunham; Joane and Liz Riel, as well as Mary and Matthew Haggerty were completed. It was also mentioned that Mary Dahl is now a lifetime member.

Treasurer B.A. indicated that TCVESSA's account balance is now \$13,610.04.

Kathy mentioned that the club took in \$3,700.00 at last month's agility trial. Since we have not had a meeting since November, and we were running low on ribbons, Kathy stated that she made an executive decision to order approximately \$600.00 worth of ribbons. There were no other requests for money.

There was a short debrief of the January agility trial at Cloud 9. As noted above, TCVESSA made \$3,700 from the event. Kathy stated that she had an unpleasant verbal exchange with C9 owner Dawn Falk and that Dawn was quite inhospitable at the trial. Kathy mentioned that she looked into FUSION for next January's agility trial, as a result. C9 charges \$2,800.00 for the weekend rental and FUSION would only charge us \$2,400.00. Courtney gave an update on the Nose Work/Scent Work seminar to be held on Feb 12/13 at the Canine Cabin in Clearwater. The instructor will be Holly Bushard. Of the 12 working spots, only 1 is still open for both days. All 6 of the audit spots, for both days, are still open. The club will provide snacks and water. A registration form is not needed, COVID waivers will need to be signed on site (for TCVESSA) and no face coverings will be required.

Alice provided the award update. She is still waiting for 2 people to send her information before she can do the final tabulation of the 2021 awards. Twenty-three dogs applied for awards and there are approximately 30 new titles. There was a discussion about the plaques which are displayed at the banquet. Does the club want to continue on that path? The process is quite an undertaking (engraving, transporting, storage 364 days a year) since they are only displayed once a year at the Annual Banquet.

Carmen stated that she has received 3 reservations for the Annual Banquet/Meeting, at Pub 42, on March 26th. She would welcome any help from members to help her set up the private dining room at 4:30 p.m. on that day. Although Carmen sent an email/PDF to all members about the Annual Banquet, Alice suggested that Carmen send a PDF directly to Jean Dockendorf, so she can add the event to the TCVESSA website. The Des Moines Specialty will be held on the weekend after the National, so it was agreed that we will decline this year.

Liz made an executive decision and said "yes" to the supported entry at Key City, which will be held around Memorial Day weekend.

Brief update on our ESS specialty in May: All Judges (4 conformation, 2 obedience/rally) are confirmed, Mike Teh will be the trial secretary and Kayla Nyvold will run the club raffle.

There was a Fast Cat discussion. Kathy has spoken to an individual named Matt who is well-versed in this area. TCVESSA will need to get licensed through AKC to have any trials. Alice suggested the Wright County Fairgrounds as a venue, should we be approved for a license. Kathy also mentioned that a weekend could support 4 trials/500 runs and could bring in \$5,100.00.

Joan mentioned that she will do a VOX soon. Julie and Diane will provide her with the approved Board Meeting minutes from October and November for publishing.

The meeting ended, however the Board continued on in a closed session for another 12 minutes.

Liz made a motion to adjourn the meeting at 8:39 p.m. Kathy seconded.

## **TCVESSA Meeting Minutes 3-3-22**

The meeting was called to order, by President Courtney Hansen, at 7:06 p.m. and took place on Zoom. TCVESSA members Mary Haggerty and Tom Lenzmeier joined the meeting.

Second readings for new applicants Maria Barton, Rita Bakalar and Demelza Holmes took place. Motion to accept – Kathy P., second – Tekla V.

Treasurer, B.A. Breese, informed all parties that we have \$11,915.47 in the bank account. There was a brief discussion about the Nose Work/Scent Work seminar which TCVESSA hosted in February. The club took in \$276.00, in profit, from the event (several participants paid for some of their entries with full volunteer cards).

### **New Business:**

Kathy P. stated that the Judge for the October agility trial is not going to be available and all local Judges are booked for that weekend. Kathy is trying to see if Mike Teh can step in. Tom L. suggested that Tom Slattery should also be contacted to see if he is available.

The May Specialty - Mike Teh will be our secretary for the show and he has all of the information he needs for the premium list. Tekla will take over the grooming and lunch reservations for the show. Liz and Diane will help with the lunches on site. There will be no welcome bags handed out to participants.

Fast Cat: There was further discussion regarding TCVESSA hosting a Fast Cat trial. Courtney and Kathy have been in contact with Matt Bixby who would bring all of the equipment. Kathy or Courtney will check into whether Matt brings anyone along to help, as the trial will need 12 volunteers to run smoothly. According to the rules there are certain jobs volunteers cannot do if they are running the same breed of dogs as the host club represents – such as the lure and timer. VOX – There was a brief discussion about moving forward to resume the VOX.

The next meeting will be on 4-14-22 at 7 p.m. on ZOOM. Liz will send out an invite to all members.

A motion was made, and seconded, to adjourn at 7:54 p.m. Motion: Liz, second: Mary Haggerty. There was no closed Board session after the meeting.
